

## Terms and conditions

ExCee

February 13, 2019

### Article 1. Definitions

In these Terms and Conditions the following definitions hold:

- a) Cover – Study association Cover.
- b) ExCee – Cover’s excursion committee, the organising party.
- c) Excursion – The organised trip from the 26<sup>th</sup> of April 2019 through the 4<sup>th</sup> of May 2019.
- d) Participation fee – The costs of registration, which covers travel- and accommodation expenses, as well as a preselection of activities.
- e) Participant – Person who has registered for the excursion.
- f) Website of the ExCee – [excee.svcover.nl](http://excee.svcover.nl).

### Article 2. Applicability

- a) These terms and conditions are applicable to all participants of the excursion as organised by the ExCee.
- b) Deviations from, and additions to, these terms and conditions are valid if and only if these are publically stated on the website of the ExCee, or are explicitly, and written, agreed upon by the participant.

### Article 3. Registration

- a) The registrations open on the 14<sup>th</sup> of February 2019.
- b) The registration deadline is on the 18<sup>th</sup> of March 2019; all registrations need to take place before that date.
- c) There are thirty available participation spots. Six thereof are reserved for the ExCee, and two for the board of Cover. The remaining twenty-two spots are assigned in order of registration.
- d) The ExCee retains the right to assign the available participation spots through an alternative method.

## Article 4. Payment

- a) The participant is obliged to pay the participation fee before the 5<sup>th</sup> of April in full. If these obligations are not met the participant can be excluded from participation by the ExCee.
- b) The participation fee is €349, barring typing and printing errors.
- c) The participation fee is based on travel and accommodation expenses. The ExCee retains the right to increase the amount of the participation until 21 days before the departure date, as a result of an increase of the aforementioned expenditures. The increase will be no more than 15% of the original participation fee. This right is extended to agreements already made.
- d) Cover's treasurer determines the payment method, which shall be published on the website of the ExCee.

## Article 5. Cancellation

- a) Cancellation by the participant must happen before the 21<sup>st</sup> of February.
- b) Cancellation by the participant after the 21<sup>st</sup> of February does not cancel their obligations to pay the participation fee.
- c) Cover's treasurer in combination with the ExCee retain the right to waive the financial obligations of a participant.

## Article 6. Provisions

- a) The ExCee is obligated to arrange for transport and accommodations during the excursion.
- b) Exceptions to the previous rule include those instances of transport and accommodation not attributed to the programme as published on the website of the ExCee.
- c) The participant is allowed to bring one item of carry-on luggage no larger than 55 by 35 by 25 centimeters. Additionally the participant is allowed to bring one accessory item no larger than 40 by 30 by 20 centimeters. The combined weight of both pieces of luggage may not exceed 12 kilograms. Unless stated otherwise in the rules of KLM at the date of departure.
- d) Any costs associated with exceeding the limites stated in the previous rule are to be payed by the participant.
- e) The ExCee is responsible for organising a preselection of activities. The payment for these activities is included in the participation fee. These activities are to be published on the website of the ExCee.
- f) The ExCee retains the right to modify the preselection of activities at any time, without giving notice to the participants.
- g) The payment method for other organised activities will be determined by Cover's treasurer in combination with the ExCee. Participants that join said activities automatically accept the costs of the activity.

## **Article 7. Accountability**

- a) Neither the ExCee nor Cover can be held responsible for any damages – financially or otherwise – suffered by the participant.

## **Article 8. Alcohol and Drugs**

- a) The consumption of drugs is prohibited during the excursion. Participants in violation of this rule may be excluded from further participation in the excursion by the ExCee.
- b) Participants under the age of 18 are prohibited from consuming alcohol during the excursion. Participants in violation of this rule may be excluded from further participation in the excursion by the ExCee.
- c) The minimum age in the previous rule is adjusted in case the legal drinking age differs in the country of residence to said legal drinking age.
- d) Excessive consumption of alcohol by a participant may result in further exclusion from participation by the ExCee.
- e) The ExCee retains the right to send a participant back to Groningen – at the participant's own expenses – in case a participant is excluded from further participation.
